PREFACE TO STUDENTS AND PARENTS

The Fine Arts Department has prepared these guidelines for band, choir and orchestra students and parents in United I.S.D.

It is United I.S.D.'s belief that participation in these organizations promote and develop a well-rounded student through emphasis of academic excellence while advocating student role models for their school. Our district also supports the premise that it is a privilege and not a right to belong to these organizations. With this in mind, these guidelines were developed to help establish uniformity with all band, choir, and orchestra programs throughout the district.

Additional sources of information important to each group can be found in the district's publication entitled Student Code of Conduct and Student Handbook and each group's individual campus handbook.

Should questions or concerns arise, parents and students should first contact the director of the group and then campus administration. For matters that are not resolved at the campus level, and after sufficient efforts have been made to do so, contact the Fine Arts Department at (956) 473-7121.

PREFACE TO STAFF MEMBERS

The Fine Arts Department and United I.S.D. seeks to have uniformity across the district with band, orchestra and choir programs. These guidelines contain standard practices within the district, UISD District policy, TEA/UIIL Side by Side policies and requirements that align with employee job descriptions. It is UISD's premise that all organizations will promote and participate in University Interscholastic League (UIL) and Texas Music Educators Association (TMEA) events and auditions. Participation in UIL/TMEA events will enhance each student's musical learning which in turn helps improve the performance of a musical group.

It is important to note that individual campus organization handbooks may not supersede or conflict with the guidelines set forth in this document

I. Enrollment/Participation

Students are eligible for membership in Band, Choir, & Orchestra by enrollment in the class and or by audition with the teacher. For high school advanced performing ensembles, placement will be determined by the TMEA audition results and the campus audition process (specific details are outlined in section V.) Students may only audition at a campus within their attendance zone or at a school where they have been officially approved for a transfer. A student who has been accepted for membership must maintain a full time student status as per Texas Education Agency (TEA) and University Interscholastic League (UIL) Guidelines.

High School students who are not enrolled in a band, choir and orchestra class due to academic graduation requirements may participate in band and choir activities and events. In order to qualify and participate in the varsity ensembles (top performing group) during concert season, class enrollment may be required by the director due to the difficulty level of the music that is performed. Class enrollment is also necessary since there are very few rehearsals after school and students not enrolled would not have sufficient rehearsal time with the full performing ensemble. Students not enrolled in the band, orchestra, choir class may participate in the other performing and competing Non-varsity ensembles provided the following conditions have been met and which also apply to all members:

- a. Attend all rehearsals held before or after school, and on weekends
- b. Attend all performances required for their group
- c. Meet musical performance requirements established by the teacher
- d. Any other requirements set forth by the teaching staff

Failure to comply with these requirements may result in demotion which may eventually lead to dismissal from the program.

II. Rehearsal/Performance Expectations

In order to maintain successful band, choir, and orchestra programs whereby students are prepared musically for all events and competitions, additional rehearsals will be necessary. The rehearsals can be scheduled by either groups or sections in each program. Teachers will conduct before or after school rehearsals Monday through Friday and sometimes on Saturdays when necessary. Furthermore, students must attend all performances and competitions scheduled for their group. Limitations on rehearsals are as follows:

1. Extra rehearsals may not exceed TEA-UIL Side by Side time constraints.

(excerpt from 19 TAC §76.1001, Subchapter AA)

(d) Limitations on practice, rehearsal, and student participation in extracurricular activities during the school week shall be as follows:

- (1) For any given extracurricular activity, a student may not participate in more than one activity per school week, excluding holidays, except as provided in paragraph (2) of this subsection.
 - (2) In addition to the limit specified in paragraph (1) of this subsection of one extracurricular activity permitted per school week, a student may also participate in a tournament or post-district contest, as well as a contest postponed by weather or public disaster that may determine advancement to a post-district level of competition.
 - (3) For each extracurricular activity, a school district must limit students to a maximum of eight hours of practice and rehearsal outside the school day per school week. (Monday through Friday)
 - (4) The Commissioner of Education recommends that school districts avoid scheduling extracurricular activities or public performances on the day or evening immediately preceding the day on which the administration of the statewide student assessment program is scheduled for Grades 3-11.
2. Rehearsals may take place on Sundays only with prior approval of the campus Principal and the Director of Fine Arts.
 3. Teachers will provide students with a calendar of events and required activities at the beginning of the school year. Students and parents must also realize that other performances not listed will occur of which participation may be required.
 4. Teachers responsible for organized extra rehearsals will open and secure the rehearsal facility.
 5. Students will be supervised during all rehearsals. A teacher will remain at the rehearsal or performance site until all students have left the area.
 6. Students may not be released from classes to perform for community requested activities without the approval of the Principal or designee.
 7. Students who have failed one or more classes may take part in performances if the following prevail: (excerpt as per 19 TAC Chapter §76)
 - a. The rehearsal/performance is an extension of the class.
 - b. The activity is required to meet the Texas Essential Knowledge and Skills (TEKS) of the class.
 - c. No admission is charged.
 - d. No competition is involved.
 - e. The activity is held on campus or a school district facility.
 8. Students who have failed, may not participate in performances if the following prevail:
 - a. There is a competition between schools.
 - b. There is a competition between students.
 - c. An admission is being charged.

Required Competitions for UISD Groups

1. U.I.L. Concert & Sight Reading Contests

Middle school and high school bands, choirs, and orchestras(Varsity, Non-Varsity) are required to participate in the U.I.L. Concert and Sight-Reading Contests each year. Non-participation due to eligibility problems will require the prior approval of the Principal and the Director of Fine Arts. Directors are to send written notification prior to the entry deadline.

2. U.I.L. Solo and Ensemble Contest and UISD Middle School Solo and Ensemble

- a. Each high school band and choir will participate in the U.I.L. Solo and Ensemble Competition held in February.
- b. Each middle school band, choir, and orchestra will participate either in the UISD Solo and Ensemble Competition held in November or the U.I.L. Solo & Ensemble Contest held in February.

3. TMEA All-District, All-Region, All-Area, All-State Competitions

Each middle school and high school band, choir, and orchestra will prepare students to participate in individual competitions that are available in their specific area. These include but not limited to Jr. High(middle school) All Region auditions, All District, All Region, All Area and All State competitions. Other competitions are Region 9th Grade, Mariachi, Jazz, and Area Orchestra auditions.

4. Other Contests

- a. Organizations may participate in other contests as long as the Principal and the Director of Fine Arts approve them.
- b. All middle school and high school bands/orchestra will participate in the UISD Band & Orchestra Evaluation.
- c. Notification of all contest results should be given to the Principal and forwarded to the Director of Fine Arts on the first week following the competition.
- d. High school marching bands may enter one out-of-town pre or post-UIL marching contest budget permitting. If a school wishes to enter more than one out-of-town pre or post-UIL marching contest, they must fund this trip from non-district budgets.

Parades

1. All middle school and high school bands will participate in a Christmas Parade (if it is endorsed by the City of Laredo), the WBCA Youth Parade (middle schools only) and the Grand Parade (high schools only).

2. For the years that Texas Music Educators Association (TMEA) conference conflicts with the WBCA parades, all UISD middle schools and high school bands must still participate in the parades as stated in number 1.

III. Grading/Assessment

School District/campus policies will be followed for grading and assessment of Band, Choir and Orchestra classes. Parents and students should know that these courses will require participation in extracurricular activities, performances and competitions as a reasonable expectation of the class. The teacher may consider the students participation in the extracurricular activity including extra rehearsals when assigning the grade for the grading period during which the extracurricular activity occurred. A student may not fail a class solely on participation in the extracurricular activity component of the class. (as per TEA-UIL Side by Side) The exception to this provision is a student who is ineligible to participate in an extracurricular activity. In this case, students shall not suffer a grade penalty for failure to participate in the extracurricular activity or public performance.

IV. Eligibility (excerpt from UIL Website)

The sole purpose of eligibility rules and contest regulations is to keep competition equitable and to maintain activities in proper perspective. It is the responsibility of each school to see that students do not compete unless they comply with all eligibility rules. It is also the responsibility of the student to observe and obey these standards. According to UIL standards, students are eligible to represent their school in interscholastic activities if they:

- have not graduated from high school,
- are full-time, day students in the school, and have been in regular attendance at the school since the 6th class day of the present school year, or have been in regular attendance for 15 or more calendar days before the contest or competition,
- are in compliance with state law and rules of the Commissioner of Education, (see TEA-UIL Side By Side) (http://www.uil.utexas.edu/policy/side_by_side.html)
- are enrolled in a four year, normal program of high school courses, and initially enrolled in the 9th grade not more than 4 years ago nor in the 10th grade not more than 3 years ago,
- were not recruited,
- are not in violation of the awards rule, and
- meet the specific eligibility requirements for academic, music and/or athletic competition.

Protecting Your Eligibility

Eligibility for Music Contests

- meet all the requirements above, and
- have not changed schools for the purpose of participating in a UIL music contest.

Extracurricular Participation Information

Eligibility No Pass, No Play (excerpt from TEA-UIL Side by Side)

A student may not participate in any extracurricular activity if a grade lower than 70 is earned in any class at the end of the six-weeks reporting period. This student may continue to participate in all practices and preparations as determined necessary by the coach, director, or sponsor of the organization during this time of ineligibility. This student may regain full eligibility status to participate in the extracurricular activity if at the end of the designated 3 weeks period all grades in all classes are equal or greater than 70. Exception: Advanced high school courses identified by the Texas Education Agency are exempted from this policy. (for additional information see the TEA-UIL Side by Side document)

Grade of Incomplete

A student with an Incomplete grade at the end of a grading period is ineligible at the end of the seven day grace period unless the Incomplete was replaced with a passing grade prior to the end of the seven day grace period.

Extra Credit Work

Extra credit work, or work (including re-test) turned in after the grading period or evaluation has ended **MAY NOT BE CONSIDERED** when determining a students eligibility for extracurricular activities except in the case of an Incomplete grade as noted above.

Definition of an Extracurricular Activity as per 19 TAC Chapter §76

(a) An extracurricular activity is an activity sponsored by the University Interscholastic League (UIL), the school district board of trustees, or an organization sanctioned by resolution of the board of trustees. The activity is not necessarily directly related to instruction of the essential knowledge and skills but may have an indirect relation to some areas of the curriculum. Extracurricular activities include, but are not limited to, public performances, contests, demonstrations, displays, and club activities, with the exception of public performances specified in paragraph (2) of this subsection.

(1) In addition, an activity shall be subject to the provisions for an extracurricular activity if any one of the following criteria apply:

(A) the activity is competitive;

(B) the activity is held in conjunction with another activity that is considered to be extracurricular;

(C) the activity is held off campus, except in a case in which adequate facilities do not exist on campus;

(D) the general public is invited; or

(E) an admission is charged.

(2) A student ineligible to participate in an extracurricular activity, but who is enrolled in a state-approved course that requires demonstration of the mastery of the essential knowledge and skills in a public performance, may participate in the performance subject to the following requirements and limitations.....

V. Auditions, Challenges and Chair Promotions

Chair/rank placement in the various performing ensembles will be based on auditions. All members must audition so they can be placed in a performing ensemble that they are best suited for. In an effort to promote the Texas Music Educators Association All State process, high school chair/rank placements will be determined by the student's ranking at the TMEA's District/Region/Area tryouts and secondly on the campus chair auditions. In the event that students did not qualify for District/Region/ Area, placement or ranking will be determined by the auditions conducted at each campus. For those students that were fully prepared to compete and miss the District auditions due to circumstances beyond their control, directors may take this into consideration during the campus auditions. Directors shall document the tryouts properly using audition forms and evaluate students individually.

Challenges may take place at the director's discretion however they will not override the ranking for those students that qualified through the District/Region/Area process. Students may challenge only one chair higher than his/her position in the band at any one time. A cut off date set by the directors will be announced and all challenges will cease. Further information may be found in the individual campus organization's handbook.

VI. Uniforms

Budget permitting, UISD will continue to provide a marching band uniform for each high school band every 8 years. Orchestra and Choir programs will also be provided with funding for adding uniforms to their programs. Middle school bands have a concert uniform that also doubles as a marching uniform. Additional uniforms such as band concert attire (tuxedos or gowns), mariachi, and specialized auxiliary uniforms will be the responsibility of each band program. Students shall be responsible for loss or damage of uniforms that are district property. Uniforms must not be altered unless approved by the director. Parents may be required to dry clean the uniform periodically.

VII. Awards

High School seniors may qualify for a school award jacket (budget permitting) provided they have maintained their membership for 4 years in the organization. Exceptions to this guideline will be handled on a case by case basis. Additional information may be found in the campus organization handbook.

VIII. Officers/Drum Majors

Band, Choir, and Orchestra directors may elect to have student officers in each organization. Student officer positions for each organization will be selected by a process as per each

organization's procedure and handbook. Officer positions are not a requirement of the district and therefore left at the discretion of each director.

All band drum major positions will be filled by auditions with one or more judges. Additional specific information regarding the audition process and requirements will be provided by the band directors prior to the auditions.

IX. Mariachi Guidelines

1. The United I.S.D. Mariachi groups are allowed to perform for all school sponsored/district sponsored events as well as community (City of Laredo) related events.
2. The Mariachi groups will not perform at social events such as weddings, quinceañeras, and private parties. Events such as retirement dinners or receptions held in honor of school or city personnel may take place provided the approval of the school principal is obtained and the students are available to perform.
3. For all performances, the head band director must be notified, and the approval of the principal must be obtained prior to accepting any performance. The director in turn, must have time to insure that the students are available to perform.
4. When traveling to an engagement, students should travel in school buses. If other arrangements must be made, waivers, and liability forms must be submitted prior to the trip.
5. Under no circumstances, are students to drive themselves and other students, to a performance during the school day. For performances held before and after school, and on the weekends, students may be transported in private vehicles provided that waivers are signed by the parents releasing the District and driver of any liability.
6. According to 19 TAC §76.1: (musical groups can perform only once per school week)
g) Limitations on practice, rehearsal, and student participation in extracurricular activities during the school week shall be as follows:

(1) For any given extracurricular activity, a student **may not** participate in more than **one activity per school week**, excluding holidays...
7. Donations for performances may be accepted (this includes Mother's Day Serenatas). These donations should be deposited in school activity accounts. **Students should not receive money for any performance.**
8. Mariachi groups must follow the U.I.L./T.E.A. Side by Side policies for all rehearsals and performances.

X. Musical Instruments and Inventory Procedures

Specific district owned musical instruments will be available for student use in band and orchestra. Beginning band members may be required to rent or purchase an instrument depending on the instrument a student wishes to play and availability. Contact the school band directors for availability of musical instruments. Students and parents are responsible for musical instruments assigned to them. Should loss or damage occur to an instrument, restitution will be required. A musical instrument and uniform maintenance fee may be required from each student when using district owned instruments/uniforms.

XI. Allowable Fees

Fine Arts students who use school owned instruments, equipment, uniforms, and accessories may be required to pay a **Maintenance/Usage** fee which is set by the district. These funds are to be collected by the director and deposited into the campus Activity Fund. The Head Director is responsible for keeping a detailed account of all funds collected. Funds collected can only be used for maintenance, replacement of instruments, accessories and uniform cleaning. Parents will be responsible for shoes, shirts/polos and any other uniform accessories.

Middle School Band instrument/uniform maintenance	\$ 30.00 per semester
Middle School Choir uniform maintenance fee	\$ 20.00 per semester
Middle School Orchestra instrument/uniform maintenance fee	\$ 30.00 per semester
High School Choir uniform maintenance fee	\$30.00 per semester
High School Band instrument maintenance/uniform fee	\$50.00 per semester

Parents that are unable to pay these fees due to personal financial reasons may request a waiver. The campus will use the information as it pertains to those students that are either on Free Lunch or Reduced to make a determination on a waiver. Students that are unable to pay the Maintenance/Usage fee will not suffer any consequences.

AUTHORIZED FEES (FP Legal) The Board may require payment of:

1. Fees for materials used in any program in which the resultant product is in excess of minimum requirements and, at the student's option, becomes the personal property of the student. Fees may not exceed the cost of materials.
2. Membership dues in student organizations or clubs, and admission fees or charges for attending extracurricular activities when membership or attendance is voluntary.
3. Security deposits for the return of materials, supplies, or equipment.

4. Fees for personal physical education and athletic equipment and apparel. However, any student may provide his or her own equipment or apparel if it meets reasonable requirements and standards relating to health and safety established by the Board.
5. Fees for items of personal use or products that a student may purchase at the student's option, such as student publications, class rings, annuals, and graduation announcements.
6. Fees specifically permitted by any other statute.
7. Fees for an authorized, voluntary student health and accident benefit plan.
8. A reasonable fee, not to exceed the actual annual maintenance cost, for the use of musical instruments and uniforms owned or rented by the District.
9. Fees for personal apparel that become the property of the student and that are used in extracurricular activities.

Education Code 11.158

XII. Student Extracurricular Insurance

The following information has been prepared for the parents and guardians of all United Independent School District athletes and students who participate in U.I.L. and extracurricular activities.

1. The United Independent School District carries accident insurance for students involved in school sponsored athletic and extracurricular activities. Your child will be covered while participating in, practicing for, and traveling to and from such an activity. Injuries occurring during regular class activities are NOT covered.
2. The insurance provided by the school is for activities that are sanctioned by U.I.L. rules and regulations and sponsored by the district. Accidents occurring during activities not directly related to the primary activity are not covered, i.e. fundraisers, car washes, etc...
3. United Independent assumes no responsibility as a result of injuries that occur during an athletic or U.I.L. event, however, this insurance is provided at school expense. This is SECONDARY INSURANCE to whatever health insurance the parent or guardian has for their children, and all claims should be filed first with the parent's primary health insurance company, second with the district insurance Co. You will need to indicate on the Student Insurance claim form the name and address of your primary insurance carrier.
4. Since this coverage is secondary, the insurance carrier will pay only after they have received information from the primary health carrier as to how much of the claim was not paid.
5. If the student has no other insurance coverage the district plan will become the primary plan and will pay accordingly. The parent or guardian should indicate on the claim form if they have no other insurance. 201 Lindenwood Dr. – Laredo, TX 78045 - (956)473-6390 - Fax (956) 473-6410

6. All policies have limitations. The district plan will only pay up to certain amounts that are listed in the schedule of benefits. Parents will be responsible for any additional amounts. (additional information may be found on the UISD website at www.uisd.net (Risk Management Department).
7. The United Independent School District and its employees are NOT responsible for any costs, treatments, or insurance claims for your child.
8. In case of an injury, it is the parent's responsibility to file a claim within 90 days of the injury. Claim forms are available in the principal's office, from the trainer, coach, sponsor, or the District Risk Management Office located at 201 Lindenwood. The coaches, trainers, sponsors or administrative personnel will be happy to assist you in completing the claim form, however, United Independent School District employees are not responsible for filing claims.
9. As with any insurance, there are policy limitations. Please review carefully the schedule of benefits. (visit <http://www.uisd.net/support/riskManagement.htm>) for more details.
10. Treatment must begin within 30 days from the injury and claims must be filed within 90 days of the first treatment. If you have any questions, please call the District Risk Management office at 473-6390, or ask your campus teachers.

XIII. UISD Drug Testing Policy

STUDENT AND PARENT/GUARDIAN CONSENT TO RANDOM DRUG TESTING

A Student and Parent/Guardian Consent to Random Drug Testing form must be completed, signed and dated by the student participant and parent/guardian. **The completed form must be turned into the respective coach, sponsor or school official before the student is allowed to participate in any activity.** A form will have to be completed for each activity the student is participating in even if the student has completed one for another activity. Each director will verify that all students participating have submitted the consent forms.

XIV. High School Marching Bands (omitted since this pertains to high school)

XV. Extracurricular Trips

Non UIL/TMEA trips may require a field trip proposal approval. The Fine Arts Department will assist fine arts personnel with these requests. For events that require travel out of the city, campus administration and Fine Arts Department approval will be required and a field trip packet must be submitted. For trips that are out of State, further approval from the Superintendent will be required **prior to announcing** this trip to students and parents.

XVII. Booster Club Guidelines

Booster clubs are not a requirement for band, orchestra and choir programs in United I.S.D. Parent or community organizations may be formed to promote the school program or to complement a particular student group or activity. Parent organizations are required to follow the UIL Booster Club Guidelines found on the UIL Website.

The Principal at each campus shall approve:

The formation of the organization, subject to approval by the Superintendent.
The constitution and bylaws of such organizations.
All activities of such organizations.

The faculty sponsor of a student group shall serve as the liaison between any group formed in connection with a student group and the District; otherwise, the Principal shall serve as the liaison.

A current list of officers of each organization shall be on file in the Principal's office of the school involved.

District booster clubs shall:

1. Be voluntary and support student activities of the school.
2. Submit all scheduled activities for approval by the campus principal.
3. Use school facilities only with the prior approval of the campus principal.
4. Not be involved in decision or policy-making activities for a student group.
5. Have no authority in directing or influencing District employees in the administration of duties.
6. Comply with administrative regulations and board policy when offering money or gifts to the District.
7. Submit a copy of current adopted bylaws and operation procedures to the campus principal and the Director of Fine Arts.

STUDENT ACTIVITY COMPLEX POLICIES

Please note these policies that must be adhered to when attending activities at UISD’s Student Activity Complex:

1. Only coke products (no cans bottles only) are allowed, even if they are donated Dasani water only.
2. When middle school groups are invited to attend HS Varsity games, a roster of students must be faxed to the Athletic Department at 473-7120 before the date of the event and copy to Fine Arts 473-7135
3. Parents are reminded that there will be admission charges to all SAC Varsity sporting events.
4. When parents are picking up students at the end of the event, if they wish to enter they would still have to pay. Therefore coordinate your departure time/pick up time with your student.
